#### **Product description**

"iQ Granit"

composed of homogenous filled plasticized PVC. Thickness between 1.9 mm and 2.13 mm, weight between 2700 g/m² and 3390 g/m².

#### Application/Limitation

Approved for use as low flame spread material, not generation excessive quantities of smoke nor toxic products in fire. Approved for use throughout the accommodation.

Approved for use as floor covering on non-combustible substrate.

The floor covering may be bonded to the substrate with "Balls F45" adhesive (used during testing). Any other adhesive has to be approved for low flame spread characteristics and low emission of smoke and toxic gases according to the Marine Equipment Directive.

Maximum gross calorific value shall be documented separately where applicable, ref. SOLAS Chapter II-2 Reg. 5.3.2

Each product is to be supplied with its manual for installation/application and maintenance.
