# **Product description**

"Glavaflex and Glavaflex XL"

Composed of elastomeric foam based on a synthetic rubber basis with density 69 – 93 kg/m³ with glue.

Max. thickness: 32 mm

Max. organic content: 60%

#### **Application/Limitation**

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for all colour variations.

Approved for use as decorative veneer on a metallic substrate with thickness of at least 0.75 mm.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

The product satisfies the requirement for maximum calorific value (ref. Solas Chapter II-2, Reg 5.3.2.2) without further testing.

Each product is to be supplied with its manual for installation and maintenance.
